Carrier concentrations and optical conductivity of a band-inverted semimetal in two and three dimensions

Here we study the single-particle, electronic transport, and optical properties of a gapped system described by a simple two-band Hamiltonian with inverted valence bands. We analyze its properties in the three-dimensional (3D) and the two-dimensional (2D) case. The insulating phase changes into a metallic phase when the band gap is set to zero. The metallic phase in the 3D case is characterized by a nodal surface. This nodal surface is equivalent to a nodal ring in two dimensions. Within a simple theoretical framework, we calculate the density of states, the total and effective charge carrier concentration, the Hall concentration, and the Hall coefficient, for both 2D and 3D cases. The main result is that the three concentrations always differ from one another in the present model. These concentrations can then be used to resolve the nature of the electronic ground state. Similarly, the optical conductivity is calculated and discussed for the insulating phase. We show that there are no optical excitations in the metallic phase. Finally, we compare the calculated optical conductivity with the rule-of-thumb derivation using the joint density of states.

I. INTRODUCTION

The topological quest within solid state physics is to identify properties that originate from the so called nontrivial topology of the Bloch bands [1,2]. Many systems have been explored. Most familiar are the Dirac and Weyl semimetals, which contain a whole array of candidate materials [3]. Their common underlying feature is that the valence and conduction bands touch in one or more isolated points in the Brillouin zone [4–6]. A natural extension of the band point-touch is a band line-touch. Such materials are known as nodal-line semimetals [7–9]. Analogously, extending the idea of the nodal-line semimetal leads to the nodal-surface semimetal (NSSM), in which the bands touch over a surface spanned in the Brillouin zone [10]. This surface is equivalent to a line in the 2D case [11].

In this article, we address the simplest case of NSSMs in 3D and 2D. We also explore their gapped phase, which we refer to as the gapped semimetal phase (GSM). We analyze the single-particle intraband and interband properties of the system described by a two-band Hamiltonian. The Hamiltonian contains three free parameters and it describes the gapped (GSM) and the metallic (NSSM) phase. The energy bands' main feature is the inverted shape up to some critical energy [12,13] and a parabolic free-electron-like dispersion at energies beyond the band inversion. Initially the Fermi energy is assumed to be located in the middle of the band gap in the GSM phase or at the band touching in the NSSM phase. The Fermi energy is further

Second, we want to show how the DC and optical properties differ in the 3D and 2D cases of such semimetals. The DC quantities include the density of states per unit volume, the total and the effective concentration of the charge carriers, the Hall concentration, and the Hall coefficient. We show that very generally those concentrations differ for both GSM and NSSM phases, in 2D and in 3D. Therefore, by comparing the Drude weight and the Hall concentration with the total concentration, we can determine the nature of the ground state. The discrepancies between the GSM and NSSM phases are even more evident in the optical conductivity. The NSSM phase has no optical excitations since the amplitude of the interband current matrix element is proportional to the energy gap Δ . In the GSM case, we calculate the real part of the optical conductivity within the vanishing and finite interband relaxation constant approximation.

Without interband relaxation, the optical conductivity has the same shape for 3D and 2D when incident photon energy is just above the band gap. It has a square-root singularity $\operatorname{Re} \sigma(\Omega) \propto (\Omega - \Delta)^{-1/2}$. For large energies, the conductivity scales with the dimension *D* as $\operatorname{Re} \sigma(\Omega) \propto \Omega^{D/2-3}$.

manipulated by doping of the system, by filing it up with electrons for example. Our intention is twofold. First, we want to answer the question, Can the experiments such as the electronic transport and optical measurements resolve the two possible ground states, gapped (GSM) and semimetallic (NSSM)? This tackles the main problem inherent to nearly all topological materials. Their intrinsic energy scales—energy intervals within the Bloch bands—where their topological properties can be observed is small, often not more than several milli-electron-volts. This makes it challenging to experimentally distinguish between different possible ground states.

Knowing the specific Bloch momentum dependence of the interband current vertex, we show when one can use the joint density of states rule-of-thumb calculation [14] to estimate the real part of the optical conductivity.

While the present work focuses on simple charge transport properties, the usefulness and the possible new theoretical insight from our two-band model need not stop here. As an example, the concentric Fermi surfaces may lead to a resonant electron-phonon scattering that could occur for certain carrier dopings. This would certainly have an impact on the intraband dynamical conductivity. Moreover, the question of the exciton energies in this system might lead to interesting results. The inverted bands do not provide grounds for a simple effective Schrödinger-like approach similar to the standard insulators. Another interesting aspect to investigate would be the effect of the concentric Fermi surface arising in the superconductivity. Finally, the present model might provide a playground for the Mott physics and strong correlations [15], due to the diverging single-particle density of states.

This paper is structured as follows: In the first part of the article we specify the model Hamiltonian for the GSM and NSSM phase. We then define and calculate for the 3D case the density of states, the three concentrations of charge carriers (total, effective, and Hall), and the real part of the optical conductivity. Finally, we calculate all these quantities for the 2D case.

II. TWO-BAND HAMILTONIAN

As a starting point, we define a continuum 2×2 isotropic Hamiltonian matrix that describes the general form of GSM and consequently the NSSM phase [16–18]. The Hamiltonian is

$$\hat{H} = (A - Bk^2)\sigma_z + C\sigma_x, \qquad (2.1)$$

where σ_x and σ_z are the Pauli matrices and *A* and *C* are positive constants representing the gap parameters. The $A - Bk^2$ is the "inverted part." It is the simplest isotropic form of a nodal surface, with k^2 being the square of the total Bloch wave vector. The positive parameter *B* can be written in a more familiar way as $B = \hbar^2/(2m^*)$. The effective mass m^* will come in handy when the DC properties are discussed in the next section. The Hamiltonian (2.1) is invariant under spatial inversion, and since it is a real matrix it is also invariant under time reversal. The latter also implies vanishing Berry curvature [19,20] making this system topologically trivial. This Hamiltonian is a simplified variant of the Bernevig-Hughes-Zhang Hamiltonian [21,22], with a constant electron-hole coupling described by the parameter *C*.

The diagonalization of Eq. (2.1) is straightforward. It gives electron-hole symmetric eigenvalues

$$\varepsilon_{\mathbf{k}}^{c,v} = \pm \sqrt{(A - Bk^2)^2 + C^2}.$$
 (2.2)

The indices c and v stand for conduction band (plus sign) and valence band (minus sign), respectively.

To make the analysis of the electron properties originating from Eq. (2.1) as general as possible, we scale the eigenvalues Eq. (2.2) to the gap parameter A and introduce dimensionless substitutions. These substitutions are a dimensionless gap $\Delta = C/A$ and a dimensionless wave vector $\kappa^2 = k^2 B/A$. In




FIG. 1. (a) Valence bands Eq. (2.3) of the GSM case in 1D. The inverted conduction band (orange) spans the energy range between ω_b (green) and ω_t (red). The dashed line indicates the Fermi energy ω_F . In the NSSM phase, the bands touch on the surface of a circle of radius κ_0 , while in the GSM phase κ_0 is the position of minimum (maximum) of the conduction (valence) band. (b) Analogous valence bands in 2D. (c) The Fermi surface of the 3D system in the case of a partially filled conduction band with the Fermi energy in the range $\omega_b < \omega_F < \omega_t$ as depicted by the black level in panel (a).

this way, the eigenvalues above become much simpler:

$$\omega_{\kappa} = \pm \sqrt{(1 - \kappa^2)^2 + \Delta^2}, \qquad (2.3)$$

with the definition $\omega_{\kappa} = \varepsilon_{\mathbf{k}}^{c,v} / A$.

The dispersions given by Eq. (2.3) are shown in Fig. 1. Bands for the 1D $\mathbf{k} = (k_x, 0, 0)$ and 2D case are shown, together with the Fermi surface in 3D. The height of the band inversion is described by the parameter *A*, while *C* gives the minimum band separation. In dimensionless units this differentiates the two phases, GSM and NSSM. From Eq. (2.3) for GSM we have $\Delta > 0$, and for NSSM $\Delta = 0$. In the three-dimensional NSSM case the two bands touch along the spherical surface of radius $\kappa_0 = 1$. The sphere becomes a circle in 2D. In the 1D case we can depict $2\kappa_0$ in Fig. 1(a), as the distance between the two points where the bands touch.

If the value of the Fermi energy ω_F is restricted to $\omega_b < \omega_F < \omega_t$, the Fermi surface consists of two concentric spheres in 3D or concentric circles in 2D. With

$$\omega_b = \Delta, \qquad \omega_t = \sqrt{1 + \Delta^2},$$
 (2.4)

we designate the energy belonging to the bottom (*b*) and the top (*t*) of the inverted band as shown in Figs. 1(a) and 1(b). Energies (2.4) to a great extent determine the specific behavior of the DC concentrations and the optical response, as will be shown in the following sections. These energies, ω_b and ω_t , define the energy interval where the inverted bands directly influence the electronic transport.

III. 3D CASE: DENSITY OF STATES

Here we derive the density of states (DOS) per unit volume for the energy dispersion Eq. (2.2). The calculation is performed for the 3D case. The same procedure is applied for the 2D case later on (Sec. VI). By definition, the DOS per unit volume is

$$N(\varepsilon) = \frac{2}{V} \sum_{\mathbf{k}} \delta(\varepsilon - \varepsilon_{\mathbf{k}}).$$
(3.1)

We use the dimensionless variables defined in the previous section for carrying out the calculation. We change the sum in Eq. (3.1) into the integral in spherical coordinates

$$N(\omega) = \frac{1}{\pi^2} \sqrt{\frac{A}{B^3}} \int \kappa^2 d\kappa \,\delta\left(\omega - \sqrt{(1-\kappa^2)^2 + \Delta^2}\right). \quad (3.2)$$

The delta function in Eq. (3.2) is evaluated by decomposing it into a sum

$$\delta(\dots) = \sum_{\kappa_0} \delta(\kappa - \kappa_0) \left| \frac{\omega}{2\kappa_0 (1 - \kappa_0^2)} \right|, \qquad (3.3)$$

where κ_0 are the positive roots of the δ -function argument

$$\kappa_0^{\pm} = \sqrt{1 \pm \sqrt{\omega^2 - \omega_b^2}},\tag{3.4}$$

written with the help of a substitution $\Delta = \omega_b$, defined in Eq. (2.4). Inserting Eq. (3.3) back into Eq. (3.2), we obtain almost the final expression for DOS in 3D

$$N(\omega) = \frac{1}{\pi^2} \sqrt{\frac{A}{B^3}} \frac{|\omega|}{2} \sum_{\kappa_0} \frac{\kappa_0}{|1 - \kappa_0^2|}.$$
 (3.5)

To make roots κ_0^{\pm} real, the sub-root-function in Eq. (3.4) has to be positive. This depends on the value of ω . It is easy to check that if $\omega_b < \omega < \omega_t$, then both κ_0^+ and κ_0^- are real, since the sub-root-expression always remains positive. On the other hand, for $\omega > \omega_t$ only κ_0^+ is real. All of these restrictions on the allowed intervals of ω and on the sum over any function of κ_0 can be encoded into $f(\kappa_0)$ with the help of the Heaviside step function $\Theta(\omega)$,

$$\sum_{\kappa_0} f(\kappa_0) = \Theta(\omega - \omega_b)\Theta(\omega_t - \omega)[f(\kappa_0^+) + f(\kappa_0^-)] + \Theta(\omega - \omega_t)f(\kappa_0^+).$$
(3.6)

Using the recipe Eq. (3.6) on Eq. (3.5) we obtain the final result for the 3D DOS, which after some trivial rearrangement of the step functions is

$$N(\omega) = N_0^{(3)} \frac{|\omega|}{\sqrt{\omega^2 - \omega_b^2}} \Theta(|\omega| - \omega_b) \Big[\Big(1 + \sqrt{\omega^2 - \omega_b^2} \Big)^{\frac{1}{2}} + \Theta(\omega_t - |\omega|) \Big(1 - \sqrt{\omega^2 - \omega_b^2} \Big)^{\frac{1}{2}} \Big].$$
(3.7)




FIG. 2. The density of states Eq. (3.7) of the 3D system derived from the energy dispersion Eq. (2.2). DOS is a function of a dimensionless parameter ω and is plotted for several values of the gap parameter, $\omega_b = \Delta$. For the case of $\Delta = 0$ (NSSM), the dome in DOS is clearly visible between the energies (-1, 1) (black line) with a maximum height of $2N_0^{(3)}$. For $\Delta > 0$ at the energy $\omega = \omega_b$, DOS has a square-root singularity, and the value at $\omega = \omega_t$ is given by red circles. For energies $\omega \gg \omega_t$, DOS is $\propto \sqrt{\omega}$, just like in the case of the 3D free electron gas.

Equation (3.7) is plotted in Fig. 2 for different values of the parameter ω_b in the units of $N_0^{(3)} = \sqrt{A}/(2\pi^2 B^{3/2})$. In the NSSM case ($\omega_b = 0$), Eq. (3.7) gives the DOS with a domelike shape between the points $\omega = \pm \omega_t = \pm 1$, as seen from definition (2.4). For a finite value of ω_b we obtain the GSM case where DOS has a square-root singularity at ω_b . Expanding Eq. (3.7), we get

$$N(\omega) \approx N_0^{(3)} \sqrt{\frac{2\omega_b}{\omega - \omega_b}}, \quad \omega \gtrsim \omega_b,$$
$$N(\omega) \approx N_0^{(3)} \sqrt{\omega}, \quad \omega \gg \omega_b.$$
(3.8)

This divergence of the DOS in the GSM phase for energies equal to the bottom of the band ω_b can be easily understood by counting the energy states and comparing their number to the 3D parabolic band insulator, where DOS $\propto \sqrt{\omega - \omega_b}$.

In the latter case, as we decrease the Fermi level, the number of states (the area of the Fermi surface) decreases to zero at ω_b and leads to a vanishing DOS. This is not so in the GSM case of the presented model. As we decrease the Fermi energy to ω_b , the Fermi surface remains a spherical shell Fig. 1, but with a huge number of states at its lowest energy. Thus the DOS diverges. Similar reasoning applies for 2D.

Figure 2 also shows the value of $N(\omega_t)$ designated by the red circles. This shows how fast $\omega_t \rightarrow \omega_b$ as we increase Δ . While ω_b determines the DOS onset, nothing spectacular happens at ω_t . In the high-energy limit we obtain the same DOS as for the 3D free electron gas.

IV. THE T = 0 DC TRANSPORT QUANTITIES IN 3D

We calculate the DC properties of the system originally in the ground state, whose Fermi energy is initially located between the valence bands, but is shifted due to the finite charge doping.

There are three concentrations of the charge carriers, for example electrons, usually associated with the DC transport. These are the total concentration *n*, the effective concentration $n_{\alpha\alpha}$, and the Hall concentration n_H . All the three concentrations are functions of the Fermi energy ω_F .

In the trivial case of a free electron gas, these three concentrations are identical. As soon as the dispersion becomes more complex, they begin to deviate from one another. This is because these charge concentrations are each associated with a different transport concept. The simplest of them is a measure of the total charge added into the system, n, and it is temperature-independent. The second and the third one, $n_{\alpha\alpha}$ and n_H , are temperature-dependent. However, in the T = 0limit, we can give each of them a simple interpretation. In that limit, $n_{\alpha\alpha}$ becomes the average electron kinetic energy at the Fermi level. Physically, from the classical Hall experiment,




FIG. 3. The total concentration *n* (blue dashed line), the effective concentration $n_{\alpha\alpha}$ (orange line), and the Hall concentration n_H (green line) are plotted in units of $n_0^{(3)}$ as functions of Fermi energy ω_F , at several values of the gap parameter Δ . The positions of Δ are designated by vertical dotted lines. It is assumed that $m^* = m_e$. The red circle is the value of $n(\omega_t)$, the green circle is the value of $n_H(\omega_m)$, while the violet circles represent the values of $n_{\alpha\alpha}(\omega_t)$.

one measures the ratio of transversal voltage and longitudinal current, in the limit of a vanishing magnetic field. This ratio is called the Hall coefficient, R_H , and has the dimension of inverse concentration. Only in the simplest version—parabolic free electron dispersion—can we trivially connect R_H with the total carrier concentration. For any more complex band dispersion, R_H can only be calculated through semiclassical Boltzmann transport equations, and the resulting concentration is called the Hall concentration n_H .

A. Total charge carrier concentration *n*

The total carrier concentration n is accessible immediately from the DOS. Using the integral representation we have

$$n(\omega_F) = A \int_0^{\omega_F} N(\omega) \, d\omega. \tag{4.1}$$

The total concentration of the intrinsic system can be controlled by chemical doping or through electrostatic doping depending on the dimension of the system. In this analysis we further neglect any influence the donor impurities have on the electronic band structure. Inserting Eq. (3.7) in the above expression we obtain

$$n(\omega_F) = n_0^{(3)} \Theta(\omega_F - \omega_b) \times \left[\left(1 + \sqrt{\omega_F^2 - \omega_b^2} \right)^{\frac{3}{2}} - \Theta(\omega_t - \omega_F) \left(1 - \sqrt{\omega_F^2 - \omega_b^2} \right)^{\frac{3}{2}} \right], \quad (4.2)$$

where we have introduced a constant for this 3D case

$$n_0^{(3)} = \frac{1}{3\pi^2} \frac{A}{B} \sqrt{\frac{A}{B}}.$$
 (4.3)

The total concentration *n* is plotted in Fig. 3 (blue dashed line) for several values of the parameter Δ . To show some of the properties of *n* as a function of the Fermi level ω_F , Eq. (4.2)

is approximated in several interesting limits of ω_F :

$$n(\omega_F \approx 0) \approx 3n_0^{(3)}\omega_F, \quad \omega_b = 0,$$

$$n(\omega_F) \approx 3n_0^{(3)}\sqrt{2\omega_b(\omega_F - \omega_b)}, \quad \omega_F \gtrsim \omega_b,$$

$$n(\omega_F) \approx n_0^{(3)}\omega_F^{3/2}, \quad \omega_F \gg \omega_b.$$
(4.4)

The concentration which corresponds to the filling of the band up to the top of the inverted parabola is $n_t = n(\omega_F = \omega_t) = 2^{3/2} n_0^{(3)}$ and is indicated in Fig. 3 by the red circle.

B. Effective charge carrier concentration $n_{\alpha\alpha}$

The effective concentration $n_{\alpha\alpha}$ defines the Drude weight. At T = 0 it is given by [23,24]

$$n_{\alpha\alpha}(\varepsilon_F) = \frac{2}{V} \sum_{\mathbf{k}} m_e v_{\alpha \mathbf{k}} v_{\alpha \mathbf{k}} \delta(\varepsilon_F - \varepsilon_{\mathbf{k}}).$$
(4.5)

Here α is a Cartesian component, m_e is the bare electron mass, and $v_{\alpha \mathbf{k}} = (1/\hbar)\partial \varepsilon_{\mathbf{k}}/\partial k_{\alpha}$ is the electron group velocity. The derivative of Eq. (2.2) is taken over $\alpha = x$ (the remaining spatial components give the same result), and inserted into Eq. (4.5). The summation is changed into integration over the dimensionless variables κ and ω . The evaluation of Eq. (4.5) is similar to the procedure outlined in the previous subsection. The result is

$$n_{\alpha\alpha}(\omega_F) = n_0^{(3)} \frac{m_e}{m^*} \frac{\sqrt{\omega_F^2 - \omega_b^2}}{\omega_F} \Theta(\omega_F - \omega_b)$$
$$\times \left[\left(1 + \sqrt{\omega_F^2 - \omega_b^2} \right)^{\frac{3}{2}} + \Theta(\omega_t - \omega_F) \left(1 - \sqrt{\omega_F^2 - \omega_b^2} \right)^{\frac{3}{2}} \right]. \quad (4.6)$$

In writing Eq. (4.6) we used the definition of the effective mass m^* from Sec. II. The resulting expression is relatively similar to Eq. (4.2). Apart from the m_e/m^* and the additional prefactor, there is also a sign difference within the brackets. Comparison of $n_{\alpha\alpha}(\omega_F)$ and $n(\omega_F)$ is shown in Fig. 3. The differences and similarities between the two carrier concentrations are most noticeable in the following limits:

$$n_{\alpha\alpha}(\omega_F \approx 0) \approx 2n_0^{(3)} \frac{m_e}{m^*} \left(1 + \frac{3}{8} \omega_F^2 \right), \quad \omega_b = 0,$$

$$n_{\alpha\alpha}(\omega_F) \approx 2n_0^{(3)} \frac{m_e}{m^*} \sqrt{2(\omega_F - \omega_b)/\omega_b}, \quad \omega_F \gtrsim \omega_b,$$

$$n_{\alpha\alpha}(\omega_F) \approx n_0^{(3)} \frac{m_e}{m^*} \omega_F^{3/2}, \quad \omega_F \gg \omega_b.$$
(4.7)

Within the energy range $\omega_F \in (0, 1)$ the difference between the *n* and the $n_{\alpha\alpha}(\omega_F)$ gives a fingerprint of the NSSM phase. The former has a linear-like dependence on the Fermi energy while the later is nearly constant. The GSM phase is characterized by $(n, n_{\alpha\alpha}) \propto \sqrt{\omega_F - \omega_b}$ for ω_F just above ω_b . However, there is a subtle difference between the square-root amplitude of the two concentrations. From Fig. 3 we see a large square-root amplitude in $n_{\alpha\alpha}$, while *n* is nearly a straight line for small Δ . This behavior is flipped for bigger Δ . The value of the effective concentration at the band peak $n_{\alpha\alpha}(\omega_t)$ is diminishing as we increase Δ . This is seen by the position of the violet circles in Fig. 3. In the high-energy limit $\omega_F \gg \omega_t$, the bands (2.2) are free-electron-like with the effective mass m^* . In this limit we recover a well known property $n_{\alpha\alpha}/n = m_e/m^*$ [25].

C. Hall concentration n_H and coefficient R_H

Hall concentration n_H of conducting electrons has a fundamental role in the transport equations in the presence of a weak external magnetic field. n_H changes sign at the energies where the electrons make way for holes as the dominant charge carriers. This can be accomplished either by doping [26,27] or by changing the temperature [28,29]. The exact derivation of n_H from the semiclassical transport equations is rather complicated and can be found in [30–33]. Here we only recall the limiting low-field value of n_H for a magnetic field pointing in the *z* direction and when T = 0:

$$n_H = n_{xx} n_{yy} / n_{xy}, \tag{4.8}$$

where the concentrations n_{xx} and n_{yy} are given by Eq. (4.5). For our specific model, we have $n_{xx}n_{yy} = n_{\alpha\alpha}^2$ from Eq. (4.6), while n_{xy} is defined as

$$n_{xy} = \frac{2}{V} \sum_{\mathbf{k}} m_e \left(v_{x\mathbf{k}} v_{y\mathbf{k}} M_{\mathbf{k}}^{yx} - v_{x\mathbf{k}} v_{x\mathbf{k}} M_{\mathbf{k}}^{yy} \right) \delta(\varepsilon_F - \varepsilon_{\mathbf{k}}).$$
(4.9)

 $M_{\mathbf{k}}^{\alpha\beta}$ is a reciprocal effective mass tensor

$$M_{\mathbf{k}}^{\alpha\beta} = \frac{m_e}{\hbar^2} \frac{\partial^2 \varepsilon_{\mathbf{k}}}{\partial k_\alpha \partial k_\beta}.$$
 (4.10)

The Hall coefficient is $R_H = 1/(en_H)$ where e = -|e| is the charge of an electron. Taking the first and second derivatives of the dispersion Eq. (2.2) it is straightforward to show, Appendix A, that

$$n_{xy} = \frac{16}{V} \frac{m_e^2}{\hbar^4} B^3 \sum_{\mathbf{k}} k_x^2 \frac{(A - Bk^2)^3}{\varepsilon_{\mathbf{k}}^3} \delta(\varepsilon_F - \varepsilon_{\mathbf{k}}).$$
(4.11)

After a direct evaluation of Eq. (4.11) by the procedure outlined in Sec. III and as shown in Appendix A, we obtain an interesting result:

$$n_{xy}(\omega_F) = n(\omega_F) \frac{m_e^2}{m^{*2}} \frac{\omega_F^2 - \omega_b^2}{\omega_F^2}.$$
 (4.12)

Now we have all the ingredients to calculate the Hall concentration $n_H(\omega_F)$ from Eq. (4.8):

$$n_{H}(\omega_{F})/n_{0}^{(3)} = \Theta(\omega_{F} - \omega_{b})\Theta(\omega_{t} - \omega_{F})$$

$$\times \frac{\left[\left(1 + \sqrt{\omega_{F}^{2} - \omega_{b}^{2}}\right)^{\frac{3}{2}} + \left(1 - \sqrt{\omega_{F}^{2} - \omega_{b}^{2}}\right)^{\frac{3}{2}}\right]^{2}}{\left(1 + \sqrt{\omega_{F}^{2} - \omega_{b}^{2}}\right)^{\frac{3}{2}} - \left(1 - \sqrt{\omega_{F}^{2} - \omega_{b}^{2}}\right)^{\frac{3}{2}}}$$

$$+ \left(1 + \sqrt{\omega_{F}^{2} - \omega_{b}^{2}}\right)^{\frac{3}{2}}\Theta(\omega_{F} - \omega_{t}). \quad (4.13)$$

 n_H as a function of Fermi energy ω_F is shown in Fig. 3 (green line). To clarify the main features of n_H we expand Eq. (4.13) for specific limits of ω_F as we did in the case of n and $n_{\alpha\alpha}$:




FIG. 4. The Hall coefficient R_H for a 3D (green line) and 2D (red dashed line) system as a function of concentration n. The concentration is given in units of concentration needed to fill up the dome of the inverted band n_t . In 3D $n_t = 2^{3/2} n_0^{(3)}$ while in 2D $n_t = 2n_0$. Correspondingly, R_H is given in units of $(en_t)^{-1}$. The two regions $n < n_t$ and $n > n_t$ are divided by a vertical dotted line. Below the critical ratio of 1 (orange circle) for both 3D and 2D $R_H \sim n$, while above $R_H \propto 1/n$.

$$n_{H}(\omega_{F} \approx 0) \approx n_{0}^{(3)} \frac{4}{3\omega_{F}}, \quad \omega_{b} = 0,$$

$$n_{H}(\omega_{F}) \approx n_{0}^{(3)} \frac{4}{3\sqrt{2\omega_{b}(\omega_{F} - \omega_{b})}}, \quad \omega_{F} \gtrsim \omega_{b},$$

$$n_{H}(\omega_{F}) = n(\omega_{F}), \quad \omega_{F} \geqslant \omega_{t}.$$
(4.14)

As seen from Fig. 3, unlike *n* and $n_{\alpha\alpha}$, n_H is not a monotonic function of ω_F . It diverges in both NSSM and GSM phases when ω_F is zero or just above the bottom energy ω_b . Then as ω_F is increased it drops to a minimal value only to continue to grow again. The energy $\omega_F = \omega_m$ which corresponds to the minimum of n_H is determined by equating the first derivative of Eq. (4.13) to zero. This can be done analytically and it gives $\omega_m = \sqrt{\omega_b^2 + \eta}$, where $\eta = (3\sqrt{17} - 11)/2 \approx 0.685$. Correspondingly $n_H(\omega_m) \approx 2.694 n_0^{(3)}$, a value designated by the green circle on the *y* axes in Fig. 3. Clearly, the energy range in which n_H decreases and exhibits a minimum is within the range $[\omega_b, \omega_t]$ and is associated with the inverted part of the conduction band. Above ω_t , n_H is equal to the total concentration *n* and increases with ω_F .

Usually the Hall coefficient R_H is expressed as a function of total concentration *n*. To do so, we invert Eq. (4.2) and find ω_F as function of *n*. We then insert $\omega_F(n)$ into Eq. (4.13). For the 3D case, this procedure is done numerically, yielding $n_H(n)$ and consequently $R_H = 1/[en_H(n)]$, shown in Fig. 4 in green. R_H is plotted as a function of scaled concentration n/n_t where, as noted before, $n_t = n(\omega_t) = 2^{3/2}n_0^{(3)}$. If the concentration is small enough, then we have $R_H \sim n$. Above $n/n_t = 1$, $R_H \propto 1/n$. The maximum of R_H is located at the same point as the minimum of n_H . In scaled units this point is located at $n/n_t = n(\omega_m)/n_t \approx 0.848$, and gives the height of the peak $R_H \approx 1.05 (en_t)^{-1}$ as indicated by the green circle in Fig. 4. This shows again that the Hall coefficient is a function of total electron concentration, above the critical doping n_t , just as we expect it should be for a free electron gas. However, below this critical concentration, it has an unexpected linearlike decrease.

Finally, Eq. (4.13) applies only at T = 0. For finite temperatures the Fermi-Dirac distribution derivative replaces the delta function. This alters the end result, because of the temperature dependence of the electron chemical potential.

The results in this section clearly show that in this system all three carrier concentrations are mutually different. The intrinsic NSSM case is characterized by a zero value of n, a constant value of $n_{\alpha\alpha}$, and a diverging n_H . The intrinsic GSM phase, on the on the other hand, has a zero value of n and $n_{\alpha\alpha}$, while n_H diverges again. This difference between the concentrations is even more evident once we step down a dimension, moving from 3D to 2D.

V. OPTICAL CONDUCTIVITY

A. General optical conductivity formula

In a two-band model we can write the complex interband conductivity tensor [24,34]

$$\sigma_{\alpha}(\mathscr{E}) = \frac{2i\hbar}{V} \sum_{s \neq s' = (c,v)} \sum_{\mathbf{k}} \frac{\left|J_{\alpha \mathbf{k}}^{ss'}\right|^2}{\varepsilon_{\mathbf{k}}^s - \varepsilon_{\mathbf{k}}^{s'}} \frac{f_{\mathbf{k}}^{s'} - f_{\mathbf{k}}^s}{\varepsilon_{\mathbf{k}}^s - \varepsilon_{\mathbf{k}}^s + \varepsilon_{\mathbf{k}}^{s'} + i\Gamma},$$
(5.1)

where Γ is a phenomenological interband relaxation rate, and the Cartesian component α of the interband conductivity tensor is a function of the incident photon energy \mathscr{E} . In Eq. (5.1) the α -dependent interband current vertices $J_{\alpha \mathbf{k}}^{vc}$ are calculated from the Hamiltonian (2.1) in Appendix B. We analytically evaluate the real part of the conductivity tensor (5.1) in the $\Gamma \rightarrow 0$ limit for the two-band model Eq. (2.1). The result is

$$\operatorname{Re}\sigma_{\alpha}(\mathscr{E}) = \frac{2\hbar\pi}{V} \sum_{\mathbf{k}} |J_{\alpha\mathbf{k}}^{vc}|^2 \frac{f_{\mathbf{k}}^v - f_{\mathbf{k}}^c}{\varepsilon_{\mathbf{k}}^c - \varepsilon_{\mathbf{k}}^v} \delta(\mathscr{E} - \varepsilon_{\mathbf{k}}^c + \varepsilon_{\mathbf{k}}^v).$$
(5.2)

The Fermi-Dirac distributions in the above expression are simplified by taking into account the symmetry of the bands $\varepsilon_{\mathbf{k}}^{c} = -\varepsilon_{\mathbf{k}}^{v}$ and the fact that the expression Eq. (5.2) is finite only for $\mathscr{E} = \varepsilon_{\mathbf{k}}^{c} - \varepsilon_{\mathbf{k}}^{v} = 2\varepsilon_{\mathbf{k}}^{c}$. We define

$$\mathscr{F}(\mathscr{E}) = f_{\mathbf{k}}^{v} - f_{\mathbf{k}}^{c} = \frac{\sinh(\beta \mathscr{E}/2)}{\cosh(\beta \mu) + \cosh(\beta \mathscr{E}/2)}.$$
(5.3)

In the T = 0 case, the above expression simplifies to $\Theta(\mathscr{E} - 2\varepsilon_F)$, which describes the suppression of the interband transitions due to the Pauli blocking. Finally we arrive at a simple expression for the real part of the optical conductivity

$$\operatorname{Re}\sigma_{\alpha}(\mathscr{E}) = \frac{\mathscr{F}(\mathscr{E})}{\mathscr{E}} \frac{2\hbar\pi}{V} \sum_{\mathbf{k}} \left| J_{\alpha\mathbf{k}}^{vc} \right|^2 \delta\left(\mathscr{E} - 2\varepsilon_{\mathbf{k}}^c\right).$$
(5.4)

B. Optical conductivity of the 3D case

We now calculate the real part of the interband conductivity Re $\sigma_{\alpha}(\mathscr{E})$ defined from expression Eq. (5.4). The interband current vertex is derived in Appendix B and it is

$$J_{\alpha \mathbf{k}}^{vc} = 2 \frac{e}{\hbar} BC \frac{k_{\alpha}}{\varepsilon_{\mathbf{k}}}.$$
(5.5)

In our model, $J_{\alpha \mathbf{k}}^{vc}$ is a real quantity proportional to the band gap parameter. By inspecting the Hamiltonian (2.1) we see that by setting the off-diagonal elements (*C*) to zero, there is nothing that could induce the transition between the diagonal elements. Here this is demonstrated by the shape of $J_{x\mathbf{k}}^{vc}$ which states the same thing. We conclude that in the NSSM phase there are no optical excitations.

In the GSM phase, we insert the current vertex Eq. (5.5) into Eq. (5.4) and change the summation to the integral as we did in Sec. III. Once again, we make use of the dimensionless variables κ and Ω which we now define as $\Omega = \mathscr{E}/(2A)$. With this choice of scaling, Ω and ω become equal. This is best seen by looking at the delta function argument within the integral form of the conductivity in Eq. (5.4),

$$\operatorname{Re} \sigma_{\alpha}(\Omega) = \frac{4\sigma_0}{3\pi} \sqrt{\frac{A}{B}} \mathscr{F}(\Omega) \frac{\Omega_b^2}{\Omega^3} \times \int \kappa^4 d\kappa \,\delta(\Omega - \sqrt{(1-\kappa^2)^2 + \Delta^2}). \quad (5.6)$$

The aforementioned substitutions enable us to retain the energy scales ω_b and ω_t , which we had defined in Sec. II, and which are for this purpose renamed to Ω_b and Ω_t . The conductivity constant has been defined in the previous expression $\sigma_0 = e^2/(4\hbar)$. Omitting the index α in the conductivity from now on, the δ function in Eq. (5.6) is solved by a decomposition into a sum of roots Eq. (3.4). Using the recipe (3.6) we get

$$\operatorname{Re} \sigma(\Omega) = \sigma_0^{(3)} \frac{\Omega_b^2}{\Omega^2} \frac{\mathscr{F}(\Omega)}{\sqrt{\Omega^2 - \Omega_b^2}} \Theta(\Omega - \Omega_b)$$
$$\times \left[\left(1 - \sqrt{\Omega^2 - \Omega_b^2} \right)^{\frac{3}{2}} + \Theta(\Omega_t - \Omega) \left(1 + \sqrt{\Omega^2 - \Omega_b^2} \right)^{\frac{3}{2}} \right]. \quad (5.7)$$




FIG. 5. The real part of the optical conductivity calculated from the two-band model (2.1) in units of $\sigma_0^{(3)}$. Re $\sigma(\Omega)$ is plotted for several values of the parameter Δ as a function of a dimensionless parameter $\Omega = \mathscr{E}/(2A)$. The solid lines depict the intrinsic case $[\omega_F = 0 \rightarrow \mathscr{F}(\Omega) = 1]$ while the dashed red line gives a doped case with $\omega_F = 5 \rightarrow \mathscr{F}(\Omega) = \Theta(\Omega - \omega_F)$. All the curves represent the situation of zero interband relaxation as given by Eq. (5.7). For the specific case of $\Delta = 2$, a finite interband relaxation in Eq. (5.1) was used (green line). Orange circles represent Re $\sigma(\Omega_t)$.

Conductivity Eq. (5.7) is shown for the GSM case in Fig. 5 for several values of the gap parameter Δ in units of $\sigma_0^{(3)} = (2\sigma_0/3\pi)\sqrt{A/B}$. From the expression Eq. (5.7) we immediately see that the amplitude of Re $\sigma(\Omega)$ depends on the gap value Ω_b , which implies that the optical conductivity vanishes in the NSSM case as stated earlier. However, the most striking feature is the divergence of Re $\sigma(\Omega)$ at the energy Ω_b . This divergence is of the square-root type as can be seen from the expansion of Eq. (5.7) for Ω just above Ω_b :

$$\operatorname{Re} \sigma(\Omega) \approx \frac{2\sigma_0^{(3)}}{\sqrt{2\Omega_b(\Omega - \Omega_b)}}, \quad \Omega \gtrsim \Omega_b,$$
$$\operatorname{Re} \sigma(\Omega) \approx \sigma_0^{(3)}\Omega_b^2 \Omega^{-3/2}, \quad \Omega \gg \Omega_b.$$
(5.8)

The divergence in the optical response for the energy Ω_b is seen only in the intrinsic case, when the Fermi energy is zero and $\mathscr{F}(\Omega) = 1$. As soon as the doping becomes finite, the Pauli blockade removes this divergence from the interval of accessible excitation energies (red dashed line in Fig. 5). In the intrinsic case of a simple 3D Schrödinger-like direct-gap insulator, the onset of the optical transitions is connected with a transition between two points [35]. These two points are the top of the valence band and the bottom of the conduction band. The onset of the optical transitions of the GSM case is

characterized by the excitations of the entire surface of points from $-\omega_b$ to ω_b . This leads to the divergent response in the optical conductivity. The "amplitude" of the divergence in the real part of the conductivity is also governed by Ω_b . The lower this energy is, the more profound the singularity, as seen from Eq. (5.8) and as shown in Fig. 5 from comparing the blue curves of different shades.

A finite doping removes the divergence in the optical spectrum. Similarly, this divergence is lifted by taking a finite interband relaxation Γ in the calculation of $\text{Re }\sigma(\Omega)$. This leads to the removal of the singularity since at the Ω_b we have $\text{Re }\sigma(\Omega_b) \propto 1/\Gamma$. For even larger values of Γ , the optical response of the intrinsic case is entirely smeared, as seen in Fig. 5.

On the other hand, the high- Ω limit is proportional to Ω_b^2 and dies off quickly as we lower the value of Ω_b ; see Fig. 5. The upper dome energy Ω_t bears no significance in Re $\sigma(\Omega_t)$. Its position is depicted by the orange circles in Fig. 5. The limiting value of these orange circles approaches $\sigma_0^{(3)} 2^{3/2}$ (shown by the red circle) when Δ increases. The distance between Ω_b and Ω_t determines the width of the conductivity peak which is located between these two points. From the definition of ω_b and ω_t in Eq. (2.4), it is evident that the width decreases with increasing Δ . A final note about Eq. (5.7): the optical conductivity as a function of the photon energy \mathscr{E} and the three parameters of the Hamiltonian (2.1) A, B, and C can be easily obtained. In Eq. (5.7) we simply need to change $\Omega \to \mathscr{E}/(2A)$ and $\Omega_b \to C/A$.

VI. 2D CASE

A. DOS and the charge concentrations

So far, we have described the single-particle transport and optical properties of the 3D GSM and NSSM phases. In this




FIG. 6. The DOS of the 2D system described by the energy dispersion $\varepsilon_{\mathbf{k}}^{c,v} = \pm \sqrt{(A - Bk^2)^2 + C^2}$ [Eq. (2.2)] as a function of ω , plotted for several values of the parameter Δ . For the metallic NSSM case ($\Delta = 0$), DOS has a steplike shape (black line), while for the gapped GSM case ($\Delta > 0$) the divergences appear at $\omega_b = \Delta$. The step feature remains visible for $\omega_b < 1$. The red circles indicate $N(\omega_t)$. In the high- ω limit, DOS becomes constant.

section we repeat a similar analysis for the two-dimensional version of the system described in Sec. II. Hence, the main difference is the dimension of the integral which needs to be evaluated for various quantities. We start with writing the end result for DOS

$$N(\omega) = N_0 \frac{|\omega|}{\sqrt{\omega^2 - \omega_b^2}} \Theta(|\omega| - \omega_b) [1 + \Theta(\omega_t - |\omega|)],$$
(6.1)

where a helpful variable $N_0 = 1/(2\pi B)$ has been introduced. The DOS in Eq. (6.1) is shown in Fig. 6. The differences are apparent, when compared to its 3D analog in Fig. 2. For the NSSM case a round dome is replaced by a steplike structure spanning between $\omega \in (-1, 1)$. It has an amplitude of $2N_0$ within the $\omega \in (-1, 1)$ interval and the height of N_0 outside these boundaries. The finite gap in the GSM phase, like in its 3D analog, introduces a square-root divergence at ω_b [36]. The DOS for the NSSM case is consistent with the result obtained in [37].

The total concentration *n* is given as a function of the Fermi energy for the electron-doped case ($\omega_F > 0$). It follows from Eq. (4.1) with DOS given by Eq. (6.1):

$$n(\omega_F) = n_0 \Theta(\omega_F - \omega_b) \times \left[1 + \sqrt{\omega_F^2 - \omega_b^2} - \Theta(\omega_t - \omega_F) \left(1 - \sqrt{\omega_F^2 - \omega_b^2}\right)\right].$$
(6.2)




FIG. 7. (a) The total concentrations n Eq. (6.2) (blue dashed line), effective concentration $n_{\alpha\alpha}$ Eq. (6.3) (orange line), and the Hall concentration n_H Eq. (6.4) (green line), as a function of Fermi energy ω_F in units of n_0 for the case $m_e = m^*$. The concentrations are plotted for several values of the $\omega_b = \Delta$ whose positions are denoted by the vertical dotted lines. Particularly interesting is the NSSM case ($\omega_b = 0$), where the difference between the concentrations is the most profound. All three concentrations have a kink at the ω_t . For *n* and n_H the value at ω_t is $2n_0$ as indicated by the red dot. (b) *n* (blue dashed line), $n_{\alpha\alpha}$ from Eq. (6.6) (orange line), and n_H from Eq. (6.5) (green line) are shown as a function of *n* for several values of Δ , for the case when $m_e = m^*$. The arrow indicates the direction of increasing Δ in $n_{\alpha\alpha}$. *n* and n_H do not depend explicitly on ω_b while $n_{\alpha\alpha}$ does. Vertical dotted line designates $2n_0$, which is the concentration needed to fill the system to the top of the dome in Fig. 1(b).

Once again we introduced a useful constant for 2D concentration $n_0 = A/(2\pi B)$. The total concentration *n* is shown in Fig. 7(a) as a dashed blue line. In the NSSM case as inherited from the DOS, $n \propto \omega_F$ below and above $\omega_F = 1$ but with different slopes. At this specific energy, which in the GSM case corresponds to ω_t , the concentration has a value of $n_t = n(\omega_t) = 2n_0$ and a kink in its first derivative over ω .

The effective concentration follows in the same way as in Sec. IV B. After inserting the electron velocities in the

Eq. (4.5) and changing it into a 2D integral, we obtain

$$n_{\alpha\alpha}(\omega_F) = n_0 \frac{m_e}{m^*} \frac{\sqrt{\omega_F^2 - \omega_b^2}}{\omega_F} \Theta(\omega_F - \omega_b)$$
$$\times \left[1 + \sqrt{\omega_F^2 - \omega_b^2} + \Theta(\omega_t - \omega_F) \left(1 - \sqrt{\omega_F^2 - \omega_b^2}\right)\right]. \quad (6.3)$$

In the NSSM case, $n_{\alpha\alpha}(\omega_F)$ has a constant value up to ω_t and a linear dependence above ω_t , as seen from Fig. 7(a) where

it is depicted with an orange line. The discrepancies between n and $n_{\alpha\alpha}$ remain visible over the whole range of values of gap parameter Δ . For small values of ω_F just above the ω_b , $n_{\alpha\alpha}(\omega_F)$ has a square-root dependence on ω_F , while in the high-energy limit it goes linearly with ω_F .

The final concentration to consider is Hall concentration n_H . Since there is a small subtlety in the derivation procedure, we detail it in Appendix A using the recipe from Sec. IV C. It leads to

$$n_{H}(\omega_{F}) = n_{0} \left[\frac{2}{\sqrt{\omega_{F}^{2} - \omega_{b}^{2}}} \Theta(\omega_{F} - \omega_{b})\Theta(\omega_{t} - \omega_{F}) + \left(1 + \sqrt{\omega_{F}^{2} - \omega_{b}^{2}}\right)\Theta(\omega_{F} - \omega_{t}) \right].$$
(6.4)

Here n_H is drawn as a green line in Fig. 7(a), and it has a $\propto 1/n$ dependence below ω_t . Equivalently, it has a square-root type of divergence as a function of ω_F when $\omega_F \approx \omega_b$ (dotted vertical lines). On the other hand, for $\omega > \omega_t$, it is equal to $n_H = n$. Furthermore, inverting Eq. (6.2) to get $\omega_F(n)$ and inserting it in Eq. (6.4) we derive the Hall coefficient as a function of n:

$$n_H(n) = \frac{(2n_0)^2}{n} \Theta(2n_0 - n) + n \,\Theta(n - 2n_0). \tag{6.5}$$

 $2n_0$ is the total concentration of electrons when the conduction band is filled to the top of the dome of the inverted band ($n_t = 2n_0$). Although not in a simple fashion like (6.5), by the same procedure $n_{\alpha\alpha}$ too can be written as a function of *n*:

$$n_{\alpha\alpha}(n) = \frac{m_e}{m^*} \left[\frac{n}{\sqrt{[n/(2n_0)]^2 + \omega_b^2}} \Theta(2n_0 - n) + \frac{n(n/n_0 - 1)}{\sqrt{(n/n_0 - 1)^2 + \omega_b^2}} \Theta(n - 2n_0) \right].$$
 (6.6)

The dependence of n_H and $n_{\alpha\alpha}$ on n is depicted in Fig. 7(b). The three concentrations of the 2D system differ from one another for energies $\omega_F < \omega_t$, or for total concentration $n < 2n_0$. The differentiation between the two ground state NSSM and GSM phases now becomes easy to make. By carefully changing the doping and reading out the Drude weight $(n_{\alpha\alpha})$, one should obtain a constant in the NSSM phase for $n < 2n_0$. Another valid fingerprint of the band structure (2.1) in the 2D transport is the n_H , which diverges as 1/n for $n < 2n_0$. Unlike in the 3D case, the minimum value of n_H is now located at the energy ω_t .

In the highly doped limit, where the Fermi energy overshoots the top of the dome ω_t , or equivalently where $n > 2n_0$, we expect all three concentrations to be roughly the same, $n_H \approx n_{\alpha\alpha} \approx n$. This is to be expected since the energy dispersion (2.2) high above the dome is free-electron-like. From Eq. (6.5) we see this is true for *n* and n_H for the GSM and NSSM cases. But in this doping regime, $n_{\alpha\alpha} = n$ only in the NSSM phase, while in the GSM phase it approaches *n* asymptotically as the doping increases. The Hall coefficient as a function of n is reciprocal to Eq. (6.5):

$$R_H = \frac{n}{n_t^2 e} \Theta(n_t - n) + \frac{1}{ne} \Theta(n - n_t), \qquad (6.7)$$

and it is shown in Fig. 4 (red dashed line) as a function of n/n_t , in units of $(en_t)^{-1}$. As in the 3D case, R_H grows linearly with n until it reaches a sharp maximum at n_t with a height of $R_H = 1$. Beyond this maximum, R_H has the same 1/n dependence as its 3D analog. Previously, we could find the 3D $R_H(n)$ only numerically. Fortunately, in the 2D case, we can obtain an analytical result for R_H . This is why the two-dimensional case provides a valuable insight into the signature of the inverted bands in the T = 0 magnetotransport [27].

B. Optical conductivity of the 2D system

We obtain the integral expression for the 2D GSM optical conductivity by inserting the interband current vertex Eq. (5.5) in the real part of the interband conductivity formula Eq. (5.4). In units of Ω and dimensionless κ , it reads

$$\operatorname{Re}\sigma(\Omega) = \frac{e^2}{2\hbar} \frac{\mathscr{F}(\Omega)}{\Omega} \frac{\Omega_b^2}{\Omega^2} \int \kappa^3 d\kappa \,\delta(\Omega - \sqrt{(1-\kappa^2)^2 + \Delta^2}).$$
(6.8)

Evaluating the above integral in the same way as in Sec. III, we get

$$\operatorname{Re} \sigma(\Omega) = \sigma_0 \frac{\Omega_b^2}{\Omega^2} \frac{\mathscr{F}(\Omega)}{\sqrt{\Omega^2 - \Omega_b^2}} \Theta(\Omega - \Omega_b)$$
$$\times \left[1 + \sqrt{\Omega^2 - \Omega_b^2} + \Theta(\Omega_t - \Omega) \left(1 - \sqrt{\Omega^2 - \Omega_b^2} \right) \right]. \quad (6.9)$$

As in the 3D case, we can make use of the conductivity constant σ_0 . For a simple expression like (6.9), two limiting regimes in Ω are easily found:

$$\operatorname{Re} \sigma(\Omega) \approx \frac{2\sigma_0}{\sqrt{2\Omega_b(\Omega - \Omega_b)}}, \quad \Omega \gtrsim \Omega_b,$$
$$\operatorname{Re} \sigma(\Omega) \approx \sigma_0 \Omega_b^2 \Omega^{-2}, \quad \Omega \gg \Omega_b. \tag{6.10}$$




FIG. 8. Real part of the optical conductivity of the 2D system described by the two-band model (2.1) in units of σ_0 . Re $\sigma(\Omega)$ is plotted for several values of parameter Δ as a function of $\Omega = \mathscr{E}/(2A)$ for the intrinsic case [$\mathscr{F}(\Omega) = 1$]. The green curve (with a finite Γ) is calculated using Eq. (5.1) with $\Gamma = 0.05$ eV, while the rest are given by Eq. (6.9). The steplike feature in the DOS is not visible in the conductivity. Re $\sigma(\Omega_t)$ is depicted by orange circles. The circles approach $2\sigma_0$ as $\Delta \to \infty$ (red circle).

The conductivity Eq. (6.9) is plotted in Fig. 8 in units of σ_0 for several values of the gap parameter Δ in the intrinsic case, $\mathscr{F}(\Omega) = 1$. The high-energy tail decreases stronger than in 3D, apart from the rootlike divergence near the gap energy, which has the same shape as in the 3D case. Such a weak response would be difficult to set apart from the background, if multiple bands are present as they usually are in real systems. Re $\sigma(\Omega_t)$ is indicated by orange dots and it approaches the red dot $2\sigma_0$ as $\Delta \rightarrow \infty$. The impact of the finite interband relaxation Γ on the Re $\sigma(\Omega)$ is depicted in Fig. 8 with a green line.

VII. Re $\sigma(\Omega)$ AND THE JDOS ARGUMENT

Usually in a system with linear band dispersion the shape of the interband conductivity can be be determined by the

rule-of-thumb argument involving the joint density of states (JDOS) [14]. To show how this works, we look at Eq. (5.4) in the general two-band case:

$$\operatorname{Re}\sigma_{\alpha}(\mathscr{E}) = \frac{\mathscr{F}(\mathscr{E})}{\mathscr{E}} \frac{2\hbar\pi}{V} \sum_{\mathbf{k}} \left| J_{\alpha\mathbf{k}}^{vc} \right|^{2} \delta\left(\mathscr{E} - \left(\varepsilon_{\mathbf{k}}^{c} - \varepsilon_{\mathbf{k}}^{v}\right)\right). \quad (7.1)$$

If we assume that the interband current vertex does not depend explicitly on k, and that $J_{\alpha \mathbf{k}}^{vc} = J_{\alpha}^{vc}$, then J_{α}^{vc} can be taken outside the sum in Eq. (7.1). The remaining sum over the δ function is the definition of JDOS. If the bands have electronhole symmetry, JDOS is equivalent to DOS such that Eq. (7.1) becomes

$$\operatorname{Re}\sigma_{\alpha}(\mathscr{E}) = \frac{\hbar\pi}{2} |J_{\alpha}^{vc}|^2 \frac{\mathscr{F}(\mathscr{E})}{\mathscr{E}} N(\mathscr{E}/2), \qquad (7.2)$$

where we have used the definition of DOS (3.1). For the 3D and 2D Dirac systems [38,39] $J_{\alpha \mathbf{k}}^{vc} = ev$, where v is the Dirac velocity and hence (7.2) applies.

For the model studied in this article, the JDOS approach does not apply for small photon energies $\mathscr{E} \sim C$. It is only in the high-energy limit that Eq. (7.2) can be safely applied. The obvious reason for this is the strong **k** dependence of the current vertex (5.5). A way around it is to notice that in the high-energy limit ($\varepsilon_{\mathbf{k}} \gg C$) the dispersion Eq. (2.2) is parabolic, $\varepsilon_{\mathbf{k}} \approx Bk^2$, and isotropic. Also in this limit the inverse function $k(\varepsilon)$ is single valued, which is not the case when $\varepsilon_{\mathbf{k}} < \sqrt{A^2 + C^2}$; see Sec. III. Hence in *D* dimensions the mean square of the component is $\langle k_{\alpha}^2 \rangle = k^2/D = \varepsilon_{\mathbf{k}}/(DB)$ and the square of the *D*-dimensional interband current vertex is

$$\left|J_{\alpha\mathbf{k}}^{vc}\right|^2 \to \frac{8e^2}{\hbar^2} \frac{C^2 B}{D} \frac{1}{\mathscr{E}},\tag{7.3}$$

where we have used $\mathscr{E} = 2\varepsilon_{\mathbf{k}}$. Inserting (7.3) into Eq. (7.2) we get the same expressions, once we change $\mathscr{E} = 2A\Omega$, as

This line of reasoning for the JDOS rule of thumb is not new and can be demonstrated on the example of the massive 2D Dirac system, where, if we designate the band gap by *C*, we have $|J_{\alpha \mathbf{k}}^{vc}|^2 \propto e^2 v^2 (1 + C^2/\mathscr{E}^2)$ [40]. Since the DOS of the massive 2D Dirac system is linear in \mathscr{E} , in this case Eq. (7.2) gives an exact result for the optical conductivity.

VIII. CONCLUSIONS

We have addressed the static and dynamic transport properties of the nodal-surface semimetals and their gapped phase. The properties of these systems in three and two dimensions are described by the two-band model of the valence electrons. The main feature of this model is the inversion of the valence bands below the certain energy and parabolic-like shape for energies above it. The main question we answer is, Can we determine the electronic ground state, GSM or NSSM, by comparing the experimental and the calculated transport and optical properties?

The band inversion is responsible for a specific shape of the NSSM density of states. In the 3D case it is a domelike structure, while in the 2D case it has a steplike feature. In the GSM phase a square-root divergence occurs in the DOS at the band gap energies.

We have studied three different concentrations of the charge carriers. These are the total, effective, and Hall concentrations. We have shown that by controlling the doping and comparing the three concentrations we can conclude whether the ground state is gapped or not. This is due to the fact that both in 3D and in 2D these three concentrations differ from one another. Only for high doping (Fermi energy much larger than the band gap) do they become equal. The differences between the transport properties are more profound in 2D than in the 3D case. Still, the Hall coefficient shows remarkable similarities between 3D and 2D when plotted as a function of total concentration. It is difficult to determine the total carrier concentration of the doped system. However, as shown in this paper, the total concentration can be deduced from the plasmon edge measurements (effective concentration) and the Hall coefficient (Hall concentration), which are more experimentally accessible.

The optical properties give a definitive proof of the ground state. There are no optical excitations in the NSSM phase, since the conductivity amplitude is proportional to the band gap. The optical response of the GSM phase has a square-root divergence above the band gap threshold for both 3D and 2D with a $\sigma \propto \Omega^{-2}$ tail dependence in the 2D and a $\sigma \propto \Omega^{-3/2}$ tail in the 3D case.

Finally, the JDOS rule-of-thumb derivation of the optical conductivity is elaborated in detail. For the GSM phase it is shown to work only in the high-energy limit.

The velocity and mass tensor product within Eq. (4.9) is

$$v_{x\mathbf{k}}v_{y\mathbf{k}}M_{\mathbf{k}}^{yx} - v_{x\mathbf{k}}v_{x\mathbf{k}}M_{\mathbf{k}}^{yy} = \frac{m_e}{\hbar^4} \frac{8B^3k_x^2(A - Bk^2)^3}{\varepsilon_{\mathbf{k}}^3}.$$

First the 3D case is solved. Equation (A4) is inserted in Eq. (4.9) and the sum converted to integral with dimensionless variables. This integral contains the δ function which again is decomposed as

$$n_{xy}(\omega_F) = \frac{m_e^2}{\hbar^4} \frac{16}{3(2\pi)^2} \frac{AB}{\omega_F^2} \sqrt{\frac{A}{B}} \sum_{\kappa_0} \frac{\kappa_0^4 (1-\kappa_0)^3}{|\kappa_0(1-\kappa_0)|}.$$

The zeros κ_0 as defined in Sec. III are carefully implemented in (A5) with particular care on the \pm sign of $1 - \kappa_0^2 = \pm \sqrt{\omega_F^2 - \omega_b^2}$. This sign is preserved once taken to the power of 3. We get

or after we rearrange the Θ functions

$$n_{xy}(\omega_F) = n_0^{(3)} \frac{m_e^2}{m^{*2}} \frac{\omega_F^2 - \omega_b^2}{\omega_F^2} \Theta(\omega_F - \omega_b) \\ \times \left[\left(1 + \sqrt{\omega_F^2 - \omega_b^2} \right)^{\frac{3}{2}} - \Theta(\omega_t - \omega_F) \left(1 - \sqrt{\omega_F^2 - \omega_b^2} \right)^{\frac{3}{2}} \right].$$
(A7)

Comparing (A7) with Eq. (4.2) we conclude

$$n_{xy}(\omega_F) = n(\omega_F) \frac{m_e^2}{m^{*2}} \frac{\omega_F^2 - \omega_b^2}{\omega_F^2}.$$

In deriving Eq. (A7) we have used the definition of constant (4.3)

$$n_0^{(3)} = \frac{1}{3\pi^2} \frac{A}{B} \sqrt{\frac{A}{B}},$$

as well as $B = \hbar^2/(2m^*)$. Finally the Hall concentration follows from the definition $n_H(\omega_F) = n_{\alpha\alpha}^2(\omega_F)/n_{xy}(\omega_F)$ as written in main text.

The same procedure applies for the 2D case. First we reorganize the Θ functions within the effective concentration $n_{xx} = n_{yy} = n_{\alpha\alpha}$ Eq. (6.3):

two Bloch energies by (s, s') = (c, v) we can define the α component of the current vertex

$$J_{\alpha \mathbf{k}}^{ss'} = \sum_{\ell \ell'} \frac{e}{\hbar} \frac{\partial H_{\mathbf{k}}(\ell, \ell')}{\partial k_{\alpha}} U_{\mathbf{k}}(\ell, s) U_{\mathbf{k}}^{*}(\ell', s'), \qquad (B2)$$

where $U_{\mathbf{k}}(\ell, s)$ are the elements of unitary matrix. This matrix transforms the Hamiltonian to its diagonal form by definition $\mathbf{U}\mathbf{H}\mathbf{U}^{-1} = \mathbf{E}$, where \mathbf{E} is the eigenvalue matrix. After a tedious derivation \mathbf{U} is shown to be
